Hello Town of Chilton Residents.

I am taking time to reach out to all of you in communicating some **frequently asked** questions regarding election. We all know this November will be a busy election and if I can help you in any way before that date, I am happy to do so. Please know, if I don't have an answer for you, I will investigate and seek alternative help to answer and direct you correctly per the Wisconsin statutes.

If you have the need to contact me, I have office hours at the town office located at N4695 County Road BB, Chilton on Monday, Wednesday and Fridays from 10:00 a.m. to 3:00 p.m. or by appointment. You may leave me a voice message at the office phone number (920-849-4720) or email me at [sheilakoclerk@gmail.com](mailto:sheilakoclerk@gmail.com) as soon as possible so I may get back to you in a timely matter.

## **Frequently Asked Questions:**

### **I don't see my voter participation for the August 11, 2020 Election recorded in MyVote.**

- We are still recording voter participation from the August 11 election. Recording of voter participation can take up to 30 days after an election.

### **I want to register to vote for the November 3, 2020 Election.**

- The deadline to register on-line or by mail is Wednesday, October 14, 2020. You may register on-line at [www.myvote.wi.gov](http://www.myvote.wi.gov) ([proof of residency required](#)) or by completing the [Voter Registration Form](#) and submitting it along with a [valid proof of residency](#). Note: You must have resided at the address you provide on your Registration Form for at least 28 consecutive days prior to an election in order to vote in the Town of Chilton.
- After October 14, you will need to register in person at the Town of Chilton Clerks Office, N4695 County Road BB, Chilton. Hours are Monday, Wednesday & Friday, 10:00 a.m.–3:00 p.m., or at the polling location on Election Day, November 3, 2020. *\*I highly recommend getting registered before that date to lessen your wait time.\**

### **When will I get my ballot for the November 3 Election?**

- The first day Absentee Ballots can be mailed is Thursday, September 17, 2020. Look for it after that date. It all depends when Calumet County receives them from the printer.

### **How can I request an absentee ballot to be mailed?**

- You may request an absentee ballot by mail via [myvote.wi.gov](http://myvote.wi.gov) or in writing to [sheilakoclerk@gmail.com](mailto:sheilakoclerk@gmail.com). Please include your name, address, birthdate and photo ID. The last day to request an absentee ballot by mail is Thursday, October 29, 2020.

### **When can I return my absentee ballot?**

- Absentee ballots **must be received** at the Chilton Town Hall no later than 8 p.m. on Tuesday, November 3, 2020.

### **How can I return my absentee ballot?**

- Absentee ballots may be returned via USPS or drop box located outside the Town Hall at N4695 County Road BB, Chilton near the East entrance door. *\*The drop box is new. It will be*

emptied daily and envelopes will be placed in the fire proof room\*. **IF YOU ARE MAILING YOUR RETURNED BALLOT, PLEASE ALLOW 3 TO 5 MAILING DAYS.**

#### **When can I do in-person absentee voting?**

· In-Person absentee voting will take place starting Monday, October 19, 2020 through Friday, October 30, 2020, except weekends. Hours are during normal business hours (Monday, Wednesday and Friday, 10am to 3pm) or by a scheduled appointment. To support social distancing, I highly recommend scheduling an appointment by calling my office for a day and time "just for you".

#### **How many registered voters are in the Town of Chilton?**

· There are currently 721 registered voters.

Clarification regarding a mass mailing received from the WI Elections Commission.

1. You do not need to complete it if you already requested an absentee ballot and having been receiving a ballot in the U.S. mail from my office for past elections of 2020.
2. You do not need to complete it if you already requested an absentee ballot for the November election. If you want verification that I have received your request, please call my office or log on to [www.MyVote.wi.gov](http://www.MyVote.wi.gov) to view your status request.
3. You do not need to complete it if you plan to vote in person on November 3<sup>rd</sup>, 2020 at the polling location - N4695 County Road BB, Chilton.
4. You do not need to complete this form IF you will NOT BE voting for the November 3<sup>rd</sup>, 2020 election.
