HICKORY MEADOWS LANDFILL SITING RESOLUTION

WHEREAS, on November 29, 2022, GFL Environmental (“GFL”) notified the Town of Chilton (“Town”) of its intent to expand its existing solid waste facility in the area identified in the legal description attached as Exhibit A; and

WHEREAS, the Town wishes to participate in the negotiation and arbitration process for the proposed expansion.

RESOLVED, that pursuant to Wis. Stat. § 289.33(6), the Town does hereby state its intent to participate in the negotiation and arbitration of the siting of the GFL landfill described above; and

FURTHER RESOLVED, that the Town Clerk is authorized and directed to forward to the Waste Facility Siting Board, within seven (7) days of the passage of this Resolution, a certified copy of this Resolution so as to qualify the Town as a participating municipality in the negotiation and arbitration process; and

Part of the Southeast $\frac{1}{4}$ of Section 23, Town 19 North, Range 19 East, in the Town of Chilton, Calumet County, Wisconsin, bounded and described as follows:

Commencing at the East $\frac{1}{4}$ corner of said Section 23, T19N, R19E; Thence S00°57'04"E, 1169.77 feet along the East line of said Southeast $\frac{1}{4}$ of Section 23; Thence S89°02'56"W, 532.98 feet to the point of beginning of lands to be described; Thence S02°08'28"E, 434.67 feet; Thence N88°58'15"W, 1974.42 feet; Thence N01°11'22"W, 285.56 feet; Thence N31°43'33"W, 91.62 feet; Thence N20°49'36"W, 15.87 feet; Thence N89°24'49"E, 2017.71 feet to the point of beginning. Said Horizontal Expansion contains 803,400± square feet or 18.44± acres more or less.

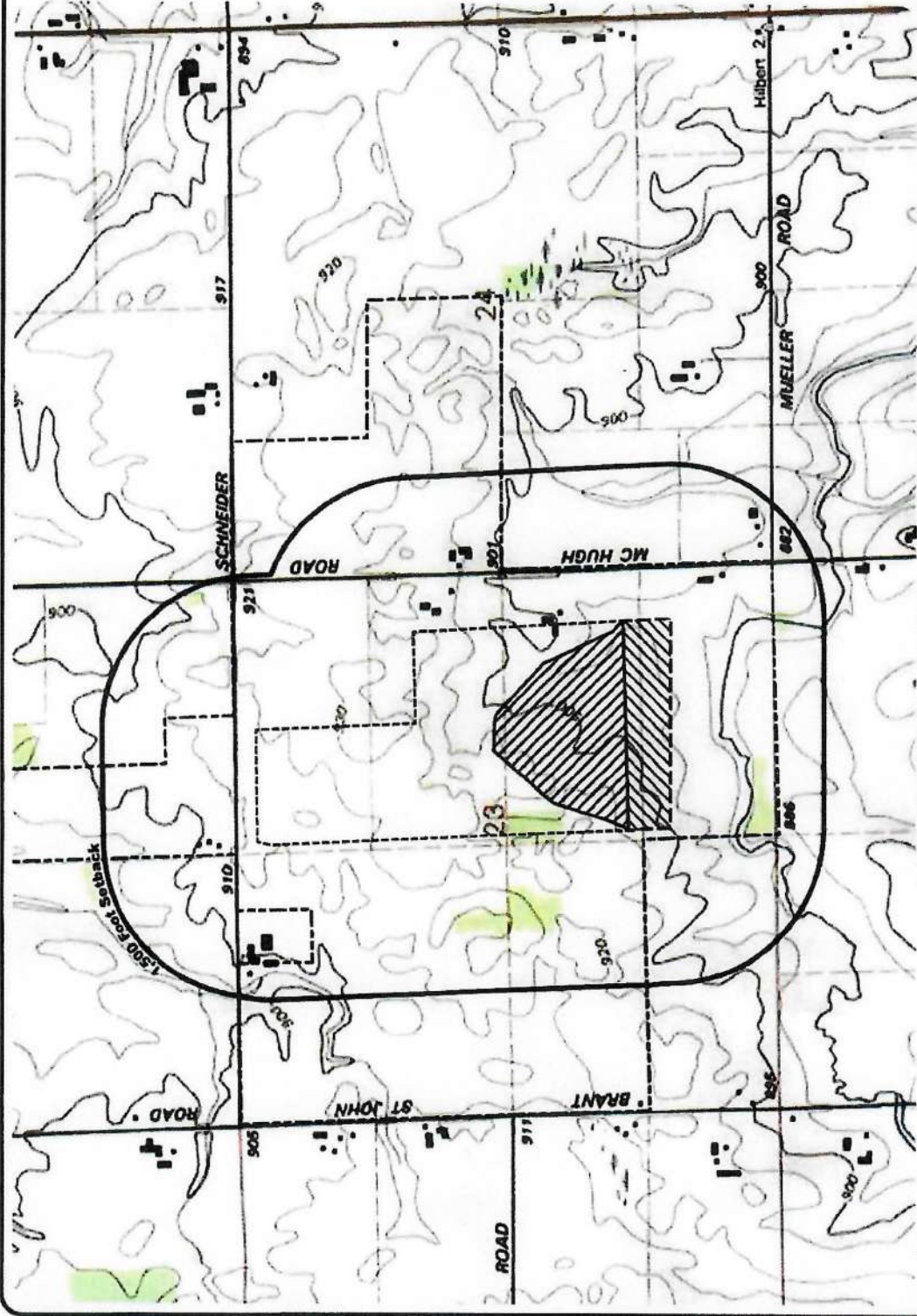
